



## OCB Beyond Nutrition Natural - April 24, 2010 – Burlington, NJ

**Notice:** The product Dream Tan is not permitted at the contest site (due to the ease in which it comes off and difficulty of cleaning it up). This was a requirement for using the facility. Plan to use other tanning products. If anyone is caught with Dream Tan at the contest site he/she will be disqualified from the competition. Spray tan service will be available, details provided below.

**Location:** Burlington, New Jersey - Burlington Township High School at the Performing Arts Center, corner of 610 Fountain Avenue at Jacksonville Road, Burlington, NJ 08016

**Show times:** Prejudging: 11:30 AM, Finals: 4:30 PM

**Divisions: Men's Bodybuilding:** Debut, Novice, 50+, 40+, Open – **Women's Bodybuilding:** 35+, Open - **Figure:** Debut, Novice, 35+, Open. *Promoter reserves the right to add or drop classes based on number of entries.*

**Division Details:** Debut Division: Open to those who have never competed before. Novice Division: Open to those who have not placed first in any class besides Teen within any division in the same category (Ex. Figure) with any organization (unless was the only competitor in the class). Eligibility will be verified during polygraph testing. Masters Divisions: Open only to those falling into the stipulated age range (ex. 40+ is age forty and over). Open Division: Open to anyone regardless of age and level of experience.

**Crossovers:** A "crossover" is entering more than one division. For example, someone may enter the Novice division, if eligible, and also elect to crossover into the Open division and compete in it as well. Crossovers between Figure and Women's Bodybuilding are not permitted.

**Check-in:** Friday April 23<sup>rd</sup> at the Host Hotel from 5pm to 8pm and Saturday April 24<sup>th</sup> at the contest venue at 8:00am sharp! Competitors not checked in by 10am Saturday will be scratched from the show. Please bring music to check-in and note competitors will collect pre-paid tickets at this time as well.

**Contestant meeting:** 10:30am at the contest venue in the auditorium

**Fees:** Entry fee: \$35 prior to March 1<sup>st</sup>. \$50 from March 1<sup>st</sup> through April 10<sup>th</sup>. \$75 from April 11<sup>th</sup> through April 22<sup>nd</sup>. Walk-in entries the day of the event will not be accepted. All entries must be received by April 22<sup>nd</sup>. Crossover entry fee: \$30 for each additional class. Polygraph Exam: \$40 (payable to the examiner at the time of testing). All fees non-refundable.

**OCB Membership:** You must be a current member of the OCB to participate in this contest. Expired membership cards will not be accepted. The annual membership fee is \$50.00 and includes a one-year subscription to *Fitness & Physique Magazine*. Competitors are encouraged to satisfy this requirement before the competition. OCB membership forms are available on the OCB website.com. Competitors may purchase memberships at check-in. Competitors will not be able to compete until this requirement is satisfied.

**Awards:** Physique sculptures for top 5 placements in each class. Best Poser and presentation award.

**Tickets:** Adult Prejudging General Admission \$15, Adult Finals General Admission \$25, Adult Combo (Valid for both show times) General Admission \$35. Age 10-18 Prejudging General Admission \$5, Age 10-18 Finals General Admission \$5, Age 10-18 Combo (Valid for both show times) General Admission \$10. Trainers Ticket ((good for general admission seating at both shows and back stage access)) \$45. Children under age 10 free.

**Photography Services:** Photography coverage will be available.

**Spray Tanning Services:** Tanning services will be available by Solstice Tanning. They will offer the ultimate alternative to messy tan creams by providing a convenient on-site spray tan the day of the show. Pre-register and save 10% so you too can lock-in your winning tan. **Drug Testing:** Polygraph testing for all competitors. Photo identification required. It is the competitors' responsibility to ensure they are polygraph tested for the event. If any competitors are not polygraph tested for the event they are ineligible for competition. Plus all competitors subject to additional forms of testing, if requested, at the discretion and expense of the promoter.

**Backstage policy:** One assistant per competitor allowed back stage, assistant MUST buy a trainers ticket, which is good for general admission and back stage access.

**Routines:** Routine length 60 seconds for bodybuilding. Figure competitors furnish their own music for stage walks at finals. Music should be at least 90 seconds long - can be faded out as competitors exit the stage area if longer than actually needed. All music is to be provided on CD only. Music should not contain any profanity. Costumes/props permitted for Bodybuilding. Props not permitted for Figure stage walks.
