



## OCB Pride of the Atlantic - May 15, 2010 – Richmond, VA

Coverage in Fitness & Physique Magazine - IFPA Bodybuilding & Figure Open & Masters Pro Qualifier – Ms. Fitness USA National Qualifier

**Notice:** The product Dream Tan is not permitted at the contest site (due to the ease in which it comes off and difficulty of cleaning it up). This was a requirement for using the facility. Plan to use other tanning products. If anyone is caught with Dream Tan at the contest site he/she will be disqualified from the competition. Spray tan service will be available, see details below.

**Location:** Maggie L. Walker Governor's School, 1000 North Lombardy St, Richmond, VA 23220

**Show times:** Pre-judging: 11:30 AM, Finals: 4:30 PM

**Divisions:** Men's Bodybuilding: Novice, Age 50+, Age 40+, Open (3 classes) – Women's Bodybuilding: Novice, Age 45+, Age 35+, Open - Figure: Novice (3 classes), Age 45+, Age 35+ (2 classes), Open (3 classes) – Fitness Model: Male, Female - Ms. Fitness: Open. Promoter reserves the right to add or drop classes based on number of entries.

**Division Details:** Novice Division: Open only to those who have not placed first in any class besides Teen within any division in the same category (Ex. Figure) with any organization (unless was the only competitor in the class). Eligibility will be verified during polygraph testing. Masters Divisions: Open only to those falling into the stipulated age range (ex. 40+ is age forty and over). Open Division: Open to anyone regardless of age and level of experience.

**Crossovers:** A "crossover" is entering more than one division. For example, someone may enter the Novice division, if eligible, and also elect to crossover into the Open division and compete in it as well. Crossovers between Figure and Women's Bodybuilding are not permitted.

**Check-in/Polygraph Test:** Friday May 14<sup>th</sup> from 4:00 PM – 9:30 PM at the host hotel or Saturday May 15<sup>th</sup> from 8:15 am – 9:30 am at the contest venue. Bring music at time of check-in. If any competitors do not report for check-in prior to 9:30am Saturday they will be scratched from the show. Promoter will contact entrants 1-2 weeks before the show to schedule appointments for check-in/testing.

**Contestant meeting:** Saturday May 15<sup>th</sup> at 10:00 am at the contest site in the auditorium

**Fees:** If entry received by or postmarked by May 1<sup>st</sup>: Entry \$45, Crossover Entry \$30 per additional class. If registering after May 1<sup>st</sup>: Entry \$60, Crossover Entry \$45 per additional class. Walk-in entries will not be accepted the day of the event. OCB Membership \$50 (if not already a current member), Polygraph Exam \$40 (payable to the examiner at the time of testing). Urine testing fee \$5. Fees non-refundable.

**Awards:** Sculptured awards for top 5 placements in each class plus best poser/presentation awards.

**Tickets:** Adult General Admission Prejudging \$15, Adult General Admission Finals \$30, Adult General Admission Combo (both shows) \$40, Under 18 General Admission Prejudging \$5, Under 18 General Admission Finals \$5, Under 18 General Admission Combo (both shows) \$10, Trainers Ticket \$45 (only applicable to those helping a competitor prepare back stage – one trainer max per competitor is permitted – trainer's tickets are good for general admission seating at both shows and back stage access). **Only cash accepted day of the event.**

**Photo/Video Services:** Stage photography coverage will be provided by OCB. Video coverage will be provided by Slade Media Group. Video cameras will not be permitted in the theatre.

**Spray Tanning Services:** Beautifully Bronzed Sunless Tanning Services uses Jan Tana products for competition tanning. At least 2 coats are recommended for competition. **Make-up Services:** Make-up service will be available from Studio 10, contact Tanya at (800) 396-6219 or [makeup@mstudio10.com](mailto:makeup@mstudio10.com) for details.

**Drug Testing:** Polygraph testing for all bodybuilding & figure competitors (If in Ms. Fitness and/or Fitness Model only, not required to take the polygraph exam). Photo identification required. It is the competitors' responsibility to ensure they are polygraph tested for the event. If any competitors are not polygraph tested for the event they are ineligible for competition. Urine testing for Figure, Men's Bodybuilding and Women's Bodybuilding Open and Masters division overall winners (in addition to their polygraph tests). Urine samples will be collected immediately after the show. It is the competitors' responsibility to ensure a sample is provided before leaving the event. If competitors do not provide samples, eligibility for IFPA pro competition will be void. Plus all competitors subject to additional forms of testing, if requested, at the discretion and expense of the promoter.

**Backstage policy:** One assistant max per competitor allowed, assistant MUST buy a trainers ticket, which is good for General Admission and back stage access.

**Routines:** Routine length 60 seconds for bodybuilding 90 seconds for Ms. Fitness. Ms. Fitness uses house music for the gown and swimwear rounds. Fitness Model uses house music for prejudging. Figure competitors and Fitness Models furnish their own music for finals. Music should be at least 90 seconds long - can be faded out as competitors exit the stage area if longer than actually needed. All music is to be provided on CD only. Music should not contain any profanity. Costumes/props permitted for Bodybuilding, Fitness Model and routine portion of Ms. Fitness. Props not permitted for Figure stage walks.

**Host Hotel:** Comfort Inn, 3200 W Broad St, Richmond, VA 23230 (1.6 miles from contest site). Group rates offered are \$69 per night. Call (800) 866-0553 to make reservation and ask for the group rate for 'OCB'. Located 3 miles from downtown Richmond, 75 miles from Hampton, VA, 105 miles from Washington D.C. 150 miles from Baltimore, MD, Roanoke, VA and Raleigh/Durham, NC. Closest airport is Richmond International Airport 9 miles away. Hotel amenities include include air conditioning, cable TV, outdoor pool, free continental breakfast and coffee, ice machine, free local calls, laundry facilities, safe deposit boxes, wake-up calls, modem/data port, and free parking.

**Directions:** **To School: South of Richmond:** Take I-95 North to the Chamberlayne Exit Number 76A. Turn left onto Chamberlayne from the exit ramp to West Leigh Street at the Bojangles Statue. Turn right on West Leigh Street, school will be on the right several blocks down the street. **East of Richmond:** Take I-64 West to I-95 North. Take the Chamberlayne Exit Number 76A. Turn left onto Chamberlayne from the exit ramp to West Leigh Street at the Bojangles Statue. Turn right on West Leigh Street. School will be on the right several blocks down the street. **North of Richmond:** Take I-95 South to the Belvidere Exit Number 76B. Turn right onto West Leigh Street at the top of the ramp and follow Leigh Street to school. **West of Richmond:** Take I-64 East to I-95 South. Take the Boulevard Exit. From Boulevard turn left onto West Leigh Street. School is on the left (corner of Leigh and Lombardy). **Broad Street Directions (from West of Richmond and Host Hotel):** Go East on Broad Street, Turn left on Allen Street, Then right on Leigh Street, School is on the left (corner of Leigh and Lombardy). **Broad Street Directions (from East of Richmond):** Go West on Broad Street, Turn right on Lombardy Street, School is on the left (corner of Lombardy and Leigh)
