



OCB Arizona Natural Physique Competition August 25, 2012 - Phoenix, AZ

Location: Mesa Arts Center, 1 East Main Street, Mesa, AZ 85211-1466

Show Times: Pre-judging: 10:00 AM, Finals: 5:00 PM

Drug Tested Event: This is a natural (drug-free) competition. All competitors must meet eligibility criteria listed in the Drug Testing Guidelines in order to participate. Competitors should review these procedures and the list of banned substances at thenaturalmusclenetwork.com/OCB/forms/DrugTestingGuidelines.pdf prior to registering.

Drug Testing: All competitors are required to be polygraph tested prior to competing. In addition, IFPA pro card winners (Bodybuilding, Bikini and Figure Open overall, Men's Bodybuilding Masters Age 40+ overall, and Women's Bodybuilding and Figure Masters Age 35+ overall winners) are required to provide urine specimens immediately after the event for urinalysis testing. Photo identification must be shown prior to polygraph tests and at the time of urine specimen collections. Any competitor not polygraph tested or any above referenced IFPA pro card winner not supplying a urine specimen immediately after the contest will be subject to disqualification. It is the competitor's responsibility to ensure a sample is provided before leaving the event. Drug testing is \$40 payable in cash to the polygraph examiner at the time of testing. Photo identification required. Polygraph testing will take place August 23 and 24, 2012 at the host hotel. Promoter will contact entrants 1 - 2 weeks before the show to schedule appointments for testing.

Membership: All competitors are required to be current members of OCB to participate in this event. Membership forms and online registration options can be found on OCBonline.com at the top of the Upcoming Events/Schedule page, or membership can be obtained at check-in for the event. Cost is \$60 for the annual membership and includes a one-year subscription to Fitness & Physique Magazine.

Division Details: Debut: First competition ever. Teen: Age 19 and under. Novice: Open only to those who have not placed first in any class besides Teen within any division in the same category (Ex. Figure) with any organization (unless was the only competitor in the class). Eligibility will be verified during polygraph testing. Masters Divisions: Open only to those falling into the stipulated age range (ex. 40+ is age forty and over). Junior: Under age 23. Open: Open to anyone regardless of age and level of experience.

Division Offerings: Men's Bodybuilding: Novice (2 classes), Age 60+, Age 50+, Age 40+, Open (4 classes) – Women's Bodybuilding: Novice, Age 35+, Open - Figure: Novice (2 classes), Age 50+, Age 40+, Age 35+, Open (3 classes) – Bikini: Age 40+, Open - Male and Female Fitness Model Open - Promoter reserves the right to add or drop classes based on number of entries.

Crossovers: A "crossover" is entering more than one division. For example, someone may enter the Figure Novice division, if eligible, and also elect to crossover into the Figure Open division and compete in it as well. Crossovers between the Figure, Bikini and Women's Bodybuilding categories are not permitted.

Awards: Niels Andersen trophies awarded to top 5 competitors in each class. Award for best poser (bodybuilding) and best model walk (figure and bikini).

Fees: Entry \$50.00 for the first entry, \$40.00 for cross-over. Entry deadline, must be postmarked by August 11, 2012. There will be a \$20.00 late fee for entries post marked after August 11, 2012. Walk-ins will be accepted the day of check-in with a \$30.00 late fee. **No walk-ins day of show.** OCB membership \$60. Drug testing \$40.00 payable in cash only. Fees are non-refundable.

Check-In/Polygraph Test: 1:00 PM - 6:00 PM Thursday, August 23, 2012 and 10:00 AM - 6:00 PM Friday, August 24, 2012 at the guest hotel. No testing the day of the show unless prior arrangements have been made. Photo identification for all athletes will be checked prior to contest and before polygraph testing. **All contestants must be able to check-in prior to 6pm Friday August 24, 2011 for this event.** Promoter will contact entrants approximately 1-2 weeks before show to schedule appointments. **COMPETITORS MUST BRING OWN MUSIC FOR ROUTINES/STAGE WALKS AT TIME OF CHECK-IN.** See details about music below.

Contestant meeting: August 25, 2012 at 9:00 AM and 4:30 PM at the Theater. Be on time.

Backstage policy: One assistant max per competitor allowed, assistant **MUST** buy a trainer/assistant ticket, which is good for general admission and back stage access. Trainer's pass is \$75.00 available at registration. Only Contestants, Trainers, Sponsors, Theater Personnel and Show Staff will be allowed in the pump up area and/or backstage. Children, family or friends will not be allowed backstage. You must make arrangements for someone to watch your children.

Pump-Up Area: Will be provided for pumping up. Competitors are welcome to bring their own equipment and mirrors as well.

Valuables: You should not bring any valuables into the competition; leave them in your hotel room or with your companions. Mesa Arts Center or Cutting Edge Productions will not be responsible for lost items.

Routines: Routine length 60 seconds for bodybuilding. Figure, Fitness Model and Bikini uses house music for prejudging and finals (60 seconds). All music is to be provided on CD only. Music should not contain any profanity. Costumes/props permitted for Bodybuilding and Fitness Model. Props not permitted for Figure and Bikini stage walks. **Competitors: Please bring your music to registration.**

Photography: A professional photographer will be available at the show taking pictures of you at your best.

Spray Tanning: Aglow Tanning, contact Katie - 480-371-6498, email Katie@aglowtanning.com or sign up on the website - aglowtanning.com. Price \$70.00 if booked prior to August 11, 2012, \$80.00 if booked August 11, 2012 or later. Price includes tanning, oil and bikini bite. They will spray tan on Friday, August 24, 2012 at the host hotel. They will be available backstage for touch-ups before you go onstage. Aglow Tanning also provides hair and makeup. Check website for pricing.

Tickets: Adult General Admission Prejudging - \$12.00, Children 12 and under - \$5.00. Adult Finals - \$35.00, Children 12 and under - \$5.00. Adult combo - \$40.00 (prejudging and finals). All children must have a ticket **NO EXCEPTIONS**. Infants even need a ticket due to theater's fire regulations and codes. Tickets may be purchased at the Mesa Arts Center. Call the Mesa Arts Center Box Office at 480-644-6501 or visit www.mesaartscenter.com. Tickets are nonrefundable.
